RESOLUTION OF LOCAL AGENCY FORMATION COMMISSION
OF THE COUNTY OF SISKIYOU MAKING DETERMINATIONS
AND APPROVING THE PROPOSED COMMUNITY SERVICES
DISTRICT FORMATION, DESIGNATED AS: LAKE SHASTINA
COMMUNITY SERVICES DISTRICT

RESOLVED by the Local Agency Formation Commission of the
County of Siskiyou, State of California, that

WHEREAS, a proposal for the proposed formation of Lake
Shastina Community Service District in the County of Siskiyou was
heretofore filed by Robert Marti and accepted for filing on May 16,
1978, by the Executive Officer of this Local Agency Formation
Commission pursuant to Chapter 6.6 of Title 5, Division 2, commencing
with Section 54773 et seq. of the Government Code; and

WHEREAS, the Executive Officer, pursuant to Government Code
Section 54793, set July 28, 1978, as the hearing date of this proposal
and gave the required notice of hearing; and

WHEREAS, the Executive Officer, pursuant to Government Code
Section 54794, has reviewed this proposal and prepared a report
including his recommendations thereon, and has furnished a copy of
this report to each person entitled to a copy; and

WHEREAS, this Commission called this proposal for public hearing
on July 28, 1978, heard from the interested parties, considered the
proposal and the report of the Executive Officer, and considered the
factors determined by the Commission to be relevant to this proposal
including, but not limited to, factors specified in Government Code
Section 54796; and

WHEREAS, this Commission has reviewed and considered the negative declaration,

NOW, THEREFORE, the Local Agency Formation Commission of the County of Siskiyou DOES HEREBY RESOLVE, DETERMINE AND ORDER as follows:

Section 1. This Commission so certifies it has reviewed and considered the negative declaration,

Section 2. Subject to the terms and conditions hereinafter specified, said proposal is approved.

Section 3. The boundaries of the territory proposed to be included in the district, as set forth in the proposal or as amended by condition, are hereby approved. As described in Exhibit "A" attached. Said territory is found to be inhabited and said territory is assigned the following designation: Lake Shastina Community Services District.

Section 4. Any ordinance or resolution ordering such formation shall provide that such formation shall be made subject to the following terms and conditions:


- A.) Five (5) member Board of Directors
- B.) No tax rate established at this time, but a maximum tax rate may be established at a later date by election of qualified voters.
- C.) All services as specified in Section 61600 of Government Codes be included.

A Certificate of Compliance as to the above specified terms and conditions shall be filed with this Commission.

Section 5. The Siskiyou County Board of Supervisors is hereby authorized to initiate further proceedings for said formation as prescribed by law, providing sufficient petition can be submitted by proponents.

The foregoing resolution was introduced at a regular meeting of this Local Agency Formation Commission on the 28th day of July, 1978, by Commissioner Hayden, who moved its adoption, seconded by Commissioner Dawson, and adopted by the following vote of the Commission:
