- 1. Annexation Status update (By reference incorporated herein.) Annexation papers turned into the County Planning Department on June 16th. They are going through the process now. July 30th @ 7:30 will be closing date for comments on the submission.
- 2. Joint Committee Status Update
 The committee met on 6/18/97 and went over potential uses of the CSD property; i.e. library, post office, etc. and will further expand at the next meeting.
- C. Trespassing Program Reported on by Chief Spencer. Vehicle decals will shortly become available to residents for no charge for their cars. To allow better control of unlawful trespassing. Guest passes will be sold to residents for \$3.00 ea. 5 allowed per resident for placement on the rear view mirror. Proceeds will help to pay for the program. Total cost to be approximately \$800 and if all tags are sold it will bring in almost \$1,500 return in cost. Decal numbers will be computerized to identify owner of vehicle or guest pass. The program will be evaluated after a year. There has been more favorable input than not.

 - Shasta View Golf Village
 John Britt welcomes all the members from the Shasta View Golf
 Village. Getting final wording taken care of on the Amended
 Development Agreement dated 7/7/97. Changes were discussed.
 Page 4 # E a new paragraph has been added stating, "any cost
 incurred for the installation of the power lines to the pump
 station will be paid by SVGV. The District shall reimburse
 SVGV for 2/3 of these costs as Districts use of the pumping
 station occurs. A yearly calculation will be made of the
 amount of each payment based on the number of district
 customer hook-ups made. When 600 hook-ups occur the
 reimbursement will be paid by the District in total."
 A question of approximately \$56,000 to have electric cables
 pulled by the electric company is now being debated. Our
 original contract stated there would be no charge and that

contract was supposed to be good for 10 years. The power company now charges for that service and Public Works Superintendent Lea is still waiting to hear from PP&L on a determination regarding that original contract. That first line should read "any cost incurred for the installation of the power lines from the north end of the project to the pump station will be paid by SVGV.

Director Johns moved to approve the Amended Development Agreement dated 7/7/97 with the above paragraph "E" duly corrected as stated above added to the agreement. The motion was duly seconded by Director Brezinsky and with no further discussion and upon vote, motion carried.

Director Brezinsky moved to authorize the President and Secretary to sign the corrected copy of Amended Development Agreement dated 7/7/97. The motion was duly seconded by Director Johns and with no further discussion and upon vote, motion carried. (10-97) Mr. Tepfer added that they are looking forward to finally
