A RESOLUTION AUTHORIZING STAFF MEMBERS TO BID ON SURPLUS U.S. GOVERNMENT PROPERTY

WHEREAS, due to certain property having been declared as surplus by the State of California or by the U.S. Government and made available to public agencies at greatly reduced costs; and

WHEREAS, the Lake Shastina Community Services District, a public agency of the State of California, is authorized to participate in the bidding process for such surplus property; and

WHEREAS, such surplus property consisting of vehicles, machinery, building supplies, office supplies/furniture, etc. would be of great value to the Lake Shastina Community Services District in its daily operations and planned construction projects; and

WHEREAS, timely and rapid response to bid openings is necessary in order to be successful against competition from other public agencies.

NOW, THEREFORE, BE IT RESOLVED by the Governing Board of Lake Shastina Community Services District, and hereby ordered that the officials and/or employees whose names and titles are listed below shall be and are hereby authorized as our representatives to acquire federal surplus property from the California State Agency for Surplus Property under the Terms and Conditions set forth by the Department of General Services.
