A RESOLUTION TRANSFERRING DELINQUENT DISTRICT SERVICE FEES AND PENALTIES TO THE SISKIYOU COUNTY TAX COLLECTOR TO BE ADDED TO THE TAX ROLLS AS A LIEN AGAINST PROPERTY (PARCEL) TO WHICH SERVICES WERE PROVIDED BUT NOT PAID FOR.

RESOLVED, by the Board of Directors of the Lake Shastina Community Services District, Siskiyou County, California, as follows:

WHEREAS, pursuant to Section 61621.2 of the Government Code of the State of California a district may elect to have any, or all, rates or charges for any purpose collected on the tax roll in any forthcoming fiscal year, and,

WHEREAS, pursuant to Section 61765.3 of the Government Code of the State of California, the Board of Directors held public hearings on July 13, 1982 and August 3, 1982 to hear and consider all objections or protests, if any, and,

WHEREAS, pursuant to Article V of District Ordinance 4-80 a written report, which contained a description of each parcel of real property located within the District receiving services and the amount of the delinquency charges and penalties for each parcel in conformity with the charges prescribed by said Ordinance, was prepared and filed with the Secretary, and,


WHEREAS, pursuant to Article V of District Ordinance 4-80, the District Secretary caused notice of filing of said report and the time and place of public hearings on said report to be published once a week for two successive weeks prior to the date set for said hearing, and,

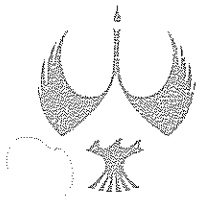
WHEREAS, pursuant to Article V of District Ordinance 4-80, the Board, upon the conclusion of the hearing on the report and having considered all objections or protests regarding the delinquent accounts listed in said report, did adopt a final version of the report.

NOW, THEREFORE BE IT RESOLVED THAT the District Secretary shall, pursuant to Government Code 61765.4 and District Ordinance 4-80 on or before the 10th day of August, 1982, file with the County Auditor of Siskiyou County a copy of said report with a statement endorsed thereon over the Secretary's signature that said report has been finally adopted by the Board of the District, and that the County Auditor shall enter the amounts of the charges against the respective lots or parcels of land as they appear on the current assessment roll to be collected at the same time and in the same manner and by the same persons as, together with and not separately from, the general taxes for the District, and shall be delinquent at the same time and thereafter be subject to the same delinquency penalties.

MINUTES

MEETING OF 3 AUGUST 1982
BOARD OF DIRECTORS
LAKE SHASTINA COMMUNITY SERVICES DISTRICT

I. ROLL CALL:

On Roll Call there were present Directors Barbier, Dutro, Sayer and Worsnop. Absent: Director Shelton.

II. PUBLIC HEARING:

No one appeared at this public hearing to protest or object regarding delinquent accounts. Upon motion made by Director Barbier, seconded by Director Sayer, the Board voted unanimously to close the public hearing.

III. RESOLUTION TO DIRECT SECRETARY TO SUBMIT LIST OF DELINQUENT ACCOUNTS TO COUNTY AUDITOR:

President Worsnop read Resolution 9-82 directing the District Secretary to submit to the County Auditor, prior to 10 August 1982, for his review and transmittal to the County Tax Collector, a list of delinquent accounts transferring service fees and penalties to be added to the tax rolls as a lien against property (parcel) to which services were provided but not paid for.

During discussion, the question was asked whether, if the County property tax portion of a tax bill were paid but not the CSD's delinquent portion, the County would still initiate a tax sale; and, if this were not the case, could the CSD initiate a tax sale. President Worsnop asked the General Manager to pursue this matter.

There being no further discussion on this matter, upon motion made by Director Barbier, seconded by Director Sayer, and upon vote carried unanimously, the Board adopted Resolution 9-82.

There being no further business to come before the Board, upon motion made by Director Sayer, seconded by Director Barbier and upon vote carried unanimously, the meeting was adjourned at 7:25 p.m.
